Before getting started let us give a brief overview of what HS Codes are.




#### Overview

The HS code contains six digits that provide information related to the product you wish to trade or get the import export data.



These six digits are divided into three parts where the first two digits are chapters the first four digits are headings and the six digits are subheadings. Each of them provides more details about the product.

The HS codes are also subdivided into 7-12 digits according to the country.

**Forming export and import data:** The HS codes allow people to collect and form the data for people who are looking for it.
